# CERTIFICATE COURSE IN GERMAN LANGUAGE 2025-2026

The College offers part-time Certificate Course in German language. The college seeks to provide skill knowledge to its students that will enhance their employability. This course is run as per the official guidelines of the University of Delhi and is affiliated to the Department of Germanic and Romance Studies, University of Delhi. At the end of the course, examinations will be conducted as per the University of Delhi schedule. Only successful students shall receive their certification documents from the college office - as and when issued by the University of Delhi.

### Eligibility Criteria-

Candidates who have passed the Senior School Certificate Examination (10+2) of the Central Board of Secondary Education, New Delhi, or an examination recognised as equivalent thereto with an aggregate of at least 45% marks are eligible to apply.

Admission will be made strictly on first come first served basis.

Saturday: 10 a.m. - 12p.m.

#### Course Fee-

Rs. 10,050/- for current students of Vivekananda College \* Rs. 13,050/- for others/ex-students of Vivekananda College\*

- The amount includes Registration fee of Rs.50/- which is non-refundable.

- Please note that Examination Fee is separate and will be charged at the time of collection of Examination forms.

- (ii). Self-attested photocopy of the certificates of Date of Birth (copy of 10<sup>th</sup> Class Board Examination Certificate)
- (iii). Self-attested photocopy of the qualifying examination (12<sup>th</sup> Class Board Examination Certificate and Mark Sheet)
- (v) Proof of University of Delhi Enrolment number (wherever applicable).

### IMPORTANT INSTRUCTIONS FOR CANDIDATE

- (i) Applicants are required to bring the above-mentioned documents in original at the time of verification/payment of fees.
- (ii) Applicants are required not to leave any column blank. Application forms with any column left blank will be deemed incomplete and will not be considered.

#### Note:

- 1. It has been observed that a large number of students face difficulty in getting their photographs and other documents attested for submission to the University/College. To avoid this difficulty, the University has decided to accept the self-attested copies of documents/papers provided by the students.
